

CAMBRIDGESHIRE COUNTY COUNCIL  
(VARIOUS STREETS, CAMBRIDGE)  
(PROHIBITION OF DRIVING)  
EXPERIMENTAL ORDER 2020

The Cambridgeshire County Council in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling powers after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1. This Order shall come into operation on the 12th day of August 2020 for a period not exceeding 18 months and may be cited as the "Cambridgeshire County Council (Various Streets, Cambridge) (Prohibition of Driving) Experimental Order 2020".
2. In this Order:  
  
"Council" means the Cambridgeshire County Council;  
  
"Motor vehicle" has the same meaning as stated in Sections 136(1) and 140 of the 1984 Act.
3. No person shall cause any motor vehicle to proceed in any of the lengths of road in Schedule 1 to this order.
4. Nothing in Article 3 shall apply to any motor vehicle being used by or on behalf of
  - (i) an individual, party or organisation authorised by the Council;
  - (ii) the police, fire brigade or ambulance service.
5. The City of Cambridge Area H (Consolidation) Order 1993 (Amendment No.2) Order 1995 is hereby varied and shall have effect as though in the Schedule to the order the following words were deleted:

"PART 6

POINTS IN ROADS BEYOND WHICH NO MOTOR VEHICLES HAVING A WIDTH GREATER THAN TWO METRES ARE PERMITTED IN ANY DIRECTION


At a point at the junction of the northern north-south arm and the west-east arm of Storey's Way formed by a barrier placed on the northeast/southwest diagonal of the junction"

6. The City of Cambridge Area A Consolidation Order 1993 is hereby varied and shall have effect as though in Schedule 6 - One-Way Streets the following words were deleted:

“Coronation Street  
(from its junction with St. Eligius  
Street to its junction with Panton  
Street)”.

## SCHEDULE 1

### Lengths of road where the driving of motor vehicles is prohibited

Bateman Street	From a point 12 metres west of the centreline of Panton Street in a westerly direction for a distance of 5 metres
Carlyle Road	From the boundary of No.34 with No.36 in both directions for a distance of 2 metres
Coronation Street	From its junction with Panton Street in a westerly direction for 5 metres
Luard Road	From a point 12 metres west of the centreline of Luard Close in a westerly direction for a distance of 3 metres
Nightingale Avenue	From the north-eastern kerb-line of the north-eastern carriageway of Hills Road in a north-easterly direction for a distance of 5 metres
Pemberton Terrace	From a point 5 metres west of the centreline of Panton Street in westerly direction for a distance of 5 metres
Storey's Way	From the western junction of the west-east arm with the north-south arm in an easterly direction for a distance of 5 metres
